## TUITION COSTS

**Basic Tuition for 2011-2012                      \$4420**

*The Association Board of Directors annually reviews and sets the basic tuition.*

## DISCOUNTS

- \$600 Association Discount - discount for members of association congregations. *(The student and parent / guardian must annually show that they are a member in good standing at an association congregation by having the pastor or his representative complete a form.)*
- 20% discount for additional children from a family *(to be calculated after the Association Discount if applicable).*

## FEES

There is a \$50 non-refundable application fee for all new students. Once the student is accepted, there is a \$150 registration fee. The annual re-registration fee varies from \$50 to \$150, based on the date of re-registration. There is a \$100 fee for enrollment in the Driver's Education program and a \$75 graduation fee. No other required fees exist. All students will be assessed the cost of the yearbook unless they specifically ask not to receive a yearbook.

## TUITION ASSISTANCE

**The ability to pay full tuition is not a criteria for enrollment at Christ Our Rock.** We seek to make it possible for all interested families to select CORLHS to educate their children. Therefore, we have established a tuition assistance program. All CORLHS families are eligible to apply. Tuition assistance is awarded based on demonstrated financial need. All tuition assistance is absolutely confidential. Application for enrollment to CORLHS must be made before a tuition assistance application will be considered. ## PAYMENT OPTIONS

- A) Pay-in-full by August 15
- B) Monthly payments—must be done through automatic withdrawal from a bank account or by credit card through RenWeb, the school and financial software used by Christ Our Rock. The minimal cost charged by RenWeb for making monthly payments is the responsibility of the family.

CORLHS seeks to help families pay tuition in a way that best fits their personal financial habits. Any exceptions to the above payment options must be requested in writing and approved by the Executive Director.

## POLICIES AND PROCEDURES

- A) The basic tuition rate for the student's first year of enrollment is the rate that is "locked in" for the rest of that student's education at CORLHS. Tuition may rise on an annual basis, but not for returning students.
- B) All tuition for the school year must be paid in full by the first day of second semester exams.
- C) Tuition will be paid according to the predetermined plan as agreed to by the parent/guardian. For returning students, the plan from the previous year shall be in effect unless a change is requested in writing.
- D) Non-payment due to non-sufficient funds will result in a fee of \$25.
- E) Services may be suspended or re-enrollment denied if tuition payments are not kept current.
- F) Enrollment at CORLHS for any portion of a quarter (grading period) constitutes a quarter of tuition.
- G) CORLHS recognizes that occasionally circumstances make it impossible to make payments on a schedule. At such a time, please contact the Executive Director to discuss options. CORLHS seeks to work with families in a proactive manner when financial situations arise.
